CURRENT:

SLHA is currently approved as a Texas Strategic Lead - System of Great Schools
 Provider and a System of Great Schools Provider through Region 13 (more info to come!)

PENDING:

- SLHA is applying to be a **School Action Fund Technical Assistance Provider** through Region 13 by October 17th (part of the LASO Cycle II grants).
- SLHA is also applying to be a District Charter School Network Technical Assistance Provider through Region 13 by October 17th.

PENDING:

 Tenet Leadership is an approved provider for Strong Foundations and TEA is working on transitioning to SLHA Advisory Services – this is still pending, however should be completed by October 23, when the grant opens.

NOTE:

When signing up for Strong Foundations training, please sign up under Tenet Leadership. Any trainings conducted as Tenet Leadership will automatically move to SLHA after the transition.



TPCSA Grants for New Charters



TPCSA Grants for New Charters

- TPCSA awarded new charters \$20,000 to use on strategic consultant services.
- Schools are required to use a consultant from the TPCSA approved provider list.
- SLHA Advisory Services is an approved provider.





- Application October 23 December 7 (must be in Qualtrics)
- · We can offer support in writing grant applications!
- **Strong Foundations Planning**: Schools put together a reading or math framework, schools DO NOT have to adopt a curriculum
 - No CURRICULUM ADOPTION REQUIRED
 - Required consultant training:
 - TEA live RBIS Training in READING AND MATH (register twice for six days), meet all requirements.
 - (Fall and Winter RBIS Registration Form)
 - To register for math and reading, you must register for ONE, and then send an email to rbis@tntp.org and ask for dates to the other one and tell them you are part of Tenet Leadership and SLHA
 - Framework (on your own): <u>SFP C2 Asynchronous Framework Sessions Attendance Form.</u>



- Strong Foundations Implementation: Schools implement Eureka or Amplify
 - Required consultant training:
 - Dates are Jan. 8-12 or Jan. 22-26, 2024
 - Requires adoption of Eureka or Amplify
 - May only be available to grade K-5



Becoming an OFFICIAL SLHA Consultant

- 1. If bring client to firm + consultant Lead Coach = profit share after expenses is 30%
- 2. DO NOT bring client to firm, but consultant Lead Coach = hourly consulting fee
- 3. Some consulting on projects as needed = hourly consulting fee
- 4. Do not coach/do not consult = receive a Client Engagement Fee


